# **Yuma USBC “Strike Out Cancer” Mail-O-Graphic Tournament**

Tournament Rules, Regulations and General Tournament Information

Please Read Carefully

1. This Yuma USBC fund raising tournament is an individual, Mail-O-Graphic Tournament. It is open to all USBC members and will be conducted by submitting USBC certified league scores bowled during 9-17 of October 2019. Bowlers may enter as many times as leagues bowled during the time frame but can only cash once per division.
2. **Handicap** - The tournament will be 90% handicap based on a 220 average for both adults and youth. Handicap will be based on the current league average for the league bowling in at time of entry. The current average used from the current league must have a minimum of 12 games bowled as of the entry date. All others are welcome to enter but will use their highest 2018-19 bluebook average.
3. **Entry Fee is \$5:** \$2 to the Susan G. Komen Foundation and \$3 for the prize fund. Make checks payable to Yuma USBC. NOTE: Any check returned from the bank will be subject to \$25 service charge.
4. **Prizes** - The prize fund will be returned 100% and will be based on a minimum of one (1) cash award for every six (6) entries. Women and men will have separate prize funds based on number of entries in each division. Youth will be paid in scholarships via SMART account #11193. **May only cash once!**
5. **Divisions** - A thru C are for adult bowlers and D thru F are for youth bowlers;  
**Division A (190 & above) Division B (189–160) and Division C (159 & Under).**  
**Division D (165 & Over) Division E (164 – 120) and Division F (119 & Under)**
6. **Disqualification** - An entrant, while participating in a scheduled event, may be disqualified for any of the following reasons: An infraction of the rules; use of foreign substance which comes into contact with the approaches or lanes; conduct derogatory to the best interest of the tournament and/or use of an illegal bowling ball. Disqualification of an individual shall result in forfeiture of the entry fee and any right to prize money and/or awards. If disqualified entire entry fee goes to the designated Charity.
7. **Falsification** - Any contestant who knowingly falsifies any information will result in forfeiture of the entry fee and any right to prize money and/or awards. Entire entry fee will go to the designated Charity.
8. **Publicity** - All participants agree to allow Yuma USBC or USBC to use their name and/or photograph for any publicity purpose. Which may include posting to the website for purpose of results or information.
9. **Disputes** - The Yuma USBC Tournament Committee shall have the power to hear and act on disputes, complaints or protests relating to the Tournament. The decision of the Committee is final except when an appeal is made to USBC.
