Yuma USBC Ultimate Mixed Tournament Rules

1. Tournament is open to all certified bowlers who are members of Yuma USBC.
2. TEAM EVENT: Bowlers age will be determined from January 19, 2019. Teams will be comprised of four (4) members. Teams must contain a bowler from each division. Divisions are:
 - A. Youth Bowler (Boy or Girl Aged 6 - 19)**
 - B. Adult Female (Aged 20 – 49)**
 - C. Adult Male (Aged 20 – 49)**
 - D. Senior Bowler (Male or Female Aged 50 – Older)**
3. AVERAGES: Participants will use their highest Sanctioned average, accepted in the following order:
 - a. Highest Book (bowl.com) average from 2017-2018 (winter or summer), 12 game minimum.
 - b. Highest current average, 12 game minimum, as of Dec. 31st, 2018
 - c. If no average available, bowler SHALL bowl Scratch (200)
 - d. USBC Rule 202d (Sport Rule) WILL APPLY
4. HANDICAP: Shall be based on 90% of the difference between team average and 800
5. SUBSTITUTES: Shall be allowed but must report at least 30 minutes prior to scheduled time to bowl with completed substitution form. Bowler must come from the same division as the person subbing for. Once a substitute starts an event (scoring), that bowler MUST complete that event.
6. LINE-UP: Shall be set as listed on the tournament entry form.
7. CHECK-IN: Will be completed no later than one half hour prior to scheduled start time and shall be completed on an INDIVIDUAL BASIS. 2018-2019 USBC membership cards SHALL be presented at Check-In.
8. TARDY BOWLERS: Bowlers or Teams arriving late will receive a zero for every frame missed and can begin play with the current frame being bowled. If a Team has an absent bowler and does not wish to have a substitute, they may use the absent bowlers AVERAGE MINUS TWENTY PINS. Only one (1) absent bowler per team may be used (Rule 322b). Absent score can only be used in Team Event.
9. ENTRY FEES: \$20.00 per bowler, \$80.00 per team. Walk-in entries will be assessed a \$5 fee per bowler. Entries submitted prior to midnight 18 January, 2019 will NOT be assessed a walk-in fee. NO ENTRY FEE WILL BE RETURNED ONCE ACCEPTED.
10. PRIZES: Plaques, trophies or similar will be awarded for 1st Place. Additional prize fund awards based on number of entries, with a 1 in 5 ratio. Prize fund and award fees shall be returned 100%, in the form of scholarships or non-monetary awards for youth bowlers.
11. DRESS CODE: Attire must be neat, clean and properly fitting. Slacks, jeans, hemmed shorts, skorts and skirts of at least mid-thigh length will be allowed. Shirts/Blouses that are not tucked in must be at least hip length. Clothing that advertises alcohol, drugs, or tobacco products or depicts foul language or gestures will not be permitted. **NO SPORT SHORTS, HATS or CAPS WILL BE ALLOWED** (allowed for medical reasons only).
12. ONLY BOWLERS AND REGISTERED VOLUNTEERS (RVP Badges) ARE ALLOWED IN THE BOWLERS AREA.
13. No electronic equipment of any kind will be allowed during competition.
14. Yuma USBC Tournament Director/Staff decisions SHALL be final.
15. CLOSING DATE: Entries MUST be turned in by midnight, January 18th, 2019. WALK-IN ENTRIES WILL BE PERMITTED, BUT WILL BE ASSESSED A WALK-IN FEE OF \$20 (\$5 PER BOWLER).
16. Any check in payment of entry fees for the tournament, returned for non-payment, will be assessed a service charge of \$25.00. Payment must be cleared prior to bowling.
17. Any rule not covered by these Tournament Rules or Yuma USBC By-Laws will be covered by USBC Tournament Rules and Regulations. Protests must be made within 72 hours of competition (Rule 329).
