## Yuma USBC Youth Tournament Rules

1. Tournament is open to all certified youth who are members of USBC.
2. EVENTS: TEAM, DOUBLES, SINGLES, and ALL EVENTS. Divisions will be according to age (determined by oldest member of team or doubles) as of August 1, 2025. Teams will be comprised of four (4) members. Teams and Doubles may be all boys, all girls or mixed.
  - A. Bantam – age 8 and under
  - B. Prep – age 9-11
  - C. Junior – age 12-14
  - D. Major – age 15-17

Tournament Director has the option of combining divisions if there are an insufficient number of entries into any division.
3. ENTRANTS: Must bowl both Doubles & Singles to bowl either. Doubles will be bowled first. Entrants may bowl more than once in team and doubles events; however, not more than two (2) players can bowl more than once as a member of the same team and no doubles team may bowl together twice. The first event score bowled shall count for All-Events.
4. AVERAGES: Participants will use their highest Sanctioned average, accepted in the following order:
  - a. Highest Book (bowl.com) average from 2024-2025 with 12 game minimum.
  - b. Highest current average, 12 game minimum, as of January 24th, 2026
  - c. If no average available, entrant SHALL bowl Scratch (200)
  - d. USBC Rule 202d (Sport Rule) WILL APPLY
5. HANDICAP: Shall be based on 90% of the difference between bowler’s average and 200 for Singles, 400 for Doubles and 800 for Team
6. SUBSTITUTES: Shall be allowed but must report at least 30 minutes prior to scheduled time to bowl with completed substitution form. Bowler will bowl in the same lineup position as the person subbing for. Once a substitute starts an event (scoring), that bowler MUST complete that event.
7. LINE-UP: Shall be set as listed on the tournament entry form.
8. CHECK-IN: Will be completed no later than 15 min. prior to scheduled start time and shall be completed on an INDIVIDUAL BASIS. 2025-2026 USBC membership cards SHALL be presented at Check-In.
9. TARDY BOWLERS: Bowlers or Teams arriving late will receive a zero for every frame missed and can begin play with the current frame being bowled. If a Team has an absent bowler and does not wish to have a substitute, they may use the absent bowlers AVERAGE MINUS TEN PINS. Only one (1) absent bowler per team may be used (Rule 322b). Absent score can only be used in Team Event. Absent Score WILL NOT count towards All-Events score.
10. ENTRY FEES: \$20.00 per event with an optional \$5.00 Handicap All-Events Fee.  
NO ENTRY FEE WILL BE RETURNED ONCE ACCEPTED.
11. PRIZES: Plaques, trophies or similar will be awarded for 1st Place in Team, Doubles, Singles & All Events. Additional awards based on number of entries per division, with a 1 in 5 ratio. TOC Entry by division (1st Place Team) shall be designated as Tournament of Champions Team Entries. All- Events Champions shall be designated as Tournament of Champions Singles Entries. Prize fund and award fees shall be returned 100%, in the form of scholarships or non-monetary awards.
13. DRESS CODE: Attire must be neat, clean and properly fitting. Slacks, jeans, hemmed shorts, skorts and skirts of at least mid-thigh length will be allowed. Shirts/Blouses that are not tucked in must be at least hip length. Clothing that advertises alcohol, drugs, or tobacco products or depicts foul language or gestures will not be permitted. *NO SPORT SHORTS, HATS or CAPS WILL BE ALLOWED* (allowed for medical reasons only).
14. ONLY BOWLERS AND REGISTERED VOLUNTEERS (RVP Badges) ARE ALLOWED IN THE BOWLERS AREA.
15. No electronic equipment of any kind will be allowed during competition.
17. Yuma USBC Tournament Director/Staff decisions SHALL be final.
18. CLOSING DATE: Entries MUST be received by 24 January 2026.
19. Any check in payment of entry fees for the tournament, returned for non-payment, will be assessed a service charge of \$25.00. Payment must be cleared prior to bowling.
20. Any rule not covered by these Tournament Rules or Yuma USBC By-Laws will be covered by USBC Tournament Rules and Regulations. Protests must be made within 72 hours of competition (Rule 329).
